TERMS OF AGREEMENT

- Lesson Fees are \$21.50 per half-hour lesson. A non-refundable minimum of 4 lessons must be paid at time of registration.
Lesson Fees for additional family members taking lessons, or additional types of lessons taken by one student are \$20.50 per half-hour.

ATTENDANCE - Students are permitted one (1) make up lesson per term when a minimum of six (6) hours notice has been given to the Music School Administrator. This canceled lesson will be credited and the payment applied to the make up lesson.

EDUCATIONAL WORKSHOPS - In lieu of regular scheduled lessons during September - June a maximum of 3 lessons may be replaced by Educational Workshops. No credits or make-up lessons will be offered if the student misses the replacement lesson.

WITHDRAWAL - Non-attendance is not confirmation of withdrawal. Students wishing to discontinue lessons must notify the Music School Administrator seven (7) days in advance. If notice is not received, the Student will continue to be charged for lessons. Upon termination of lessons, any prepaid lessons not taken will be refunded to the student (excluding those that fall within seven (7) days of withdrawal).

SUBSTITUTE INSTRUCTORS - In the event of an Instructor's absence, Quest Musique will supply a Substitute Instructor. If a Substitute Instructor is not available, you will receive a credit for the missed lesson.

LESSON PAYMENTS - All lessons are paid for in advance. Quest Musique REQUIRES that lesson payments be made through PREAUTHORIZED bank debit or credit card. The first 4 lessons must be paid for prior to starting lessons after which the automatic payments will take effect. Payment on a weekly basis are not permitted. A \$25.00 NSF Fee will be charged on ALL returned/failed payments (bank debit & credit card). Please note that the bank requires five business days to cancel preauthorized bank debit.
